2. Interim order by Hon'ble High Court, Bengaluru in WP No. 23975/2023.

The University has published the list of eligible and not-eligible candidates for admission to undergraduate programs under FN/NRI or OCI or PIO/NRI-C/NRI-S categories for the academic year 2023-2024 (vide ref. 01). Furthermore, the university authorities have taken the following decisions.

1. All candidates considered ineligible by the University are instructed to appear for the verification of original documents in compliance with the interim order of the Honorable High Court of Karnataka as per Ref (2), along with the specified deficit documents mentioned in Reference (1) supporting their application on **17.11.2023 at 10:00 am at the Veterinary College, Hebbal, Bengaluru campus.**
2. Only the deficient documents specified in Reference (1) will be accepted. Any additional documents beyond the specified reference will not be considered. Furthermore, requests for the alteration of an application from one category to another will not be permitted under any circumstances.
3. Eligible candidates who were absent for document verification on 03.11.2023 may also participate in the rescheduled document verification on 17.11.2023.
4. **Applicants who successfully completed document verification on 03.11.2023 and were confirmed as eligible as per (Annexure 1) are hereby directed to attend the counseling cum admission process scheduled for 18.11.2023 at 10:00 am at the Veterinary College, Hebbal, Bengaluru campus. Candidates undergoing document**

verification on 17.11.2023, upon confirmation of their eligibility, will be included in a combined merit list alongside those identified in Annexure – 1. This comprehensive list will be published on the University's website on 17.11.2023 after 6 PM.

5. Candidates who are provisionally admitted on 18.11.2023 are advised to come prepared to make the necessary payment of prescribed fees upon the allocation of seats.
6. All NRI-S applicants, whether Karnataka Domicile or All India, are hereby notified to submit a Notarized Affidavit of the Undertaking, as detailed in Annexure - 2 attached herewith, on a ₹100 stamp paper. The first party in the affidavit shall be the Candidate, and the second party shall be KVAFSU, Bidar.
